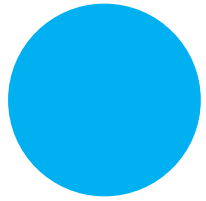

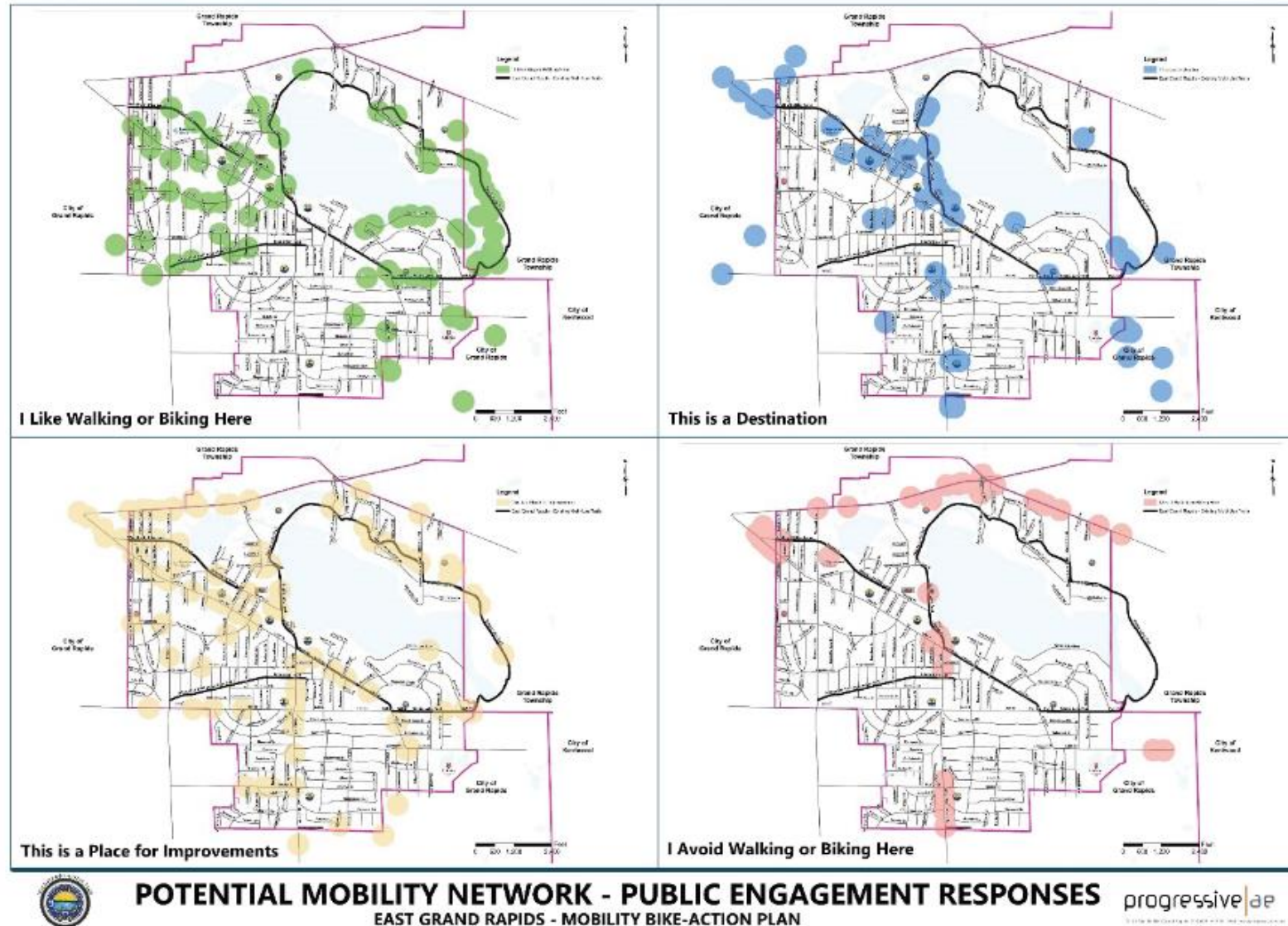

# METRICS OF SUCCESS DISCUSSION

*How will the Mobility Action Plan's success be measured?*

## Qualitative Metrics

- Surveys
- Perceived cultural shift/increased public awareness
- Mobility Action Plan utilized as guiding document for infrastructure projects

## Quantitative Metrics

- Miles of Constructed Bike Facilities
- Reduced crashes/fatalities\*
- Strava Cycling Data
- Bike Counter Data
- Increased Bike Parking Demand

*\*accounts for crashes/fatalities as a proportion (i.e. more mobility users likely leads to increased incidents; however safety improvements seek to reduce overall probability of incidents)*

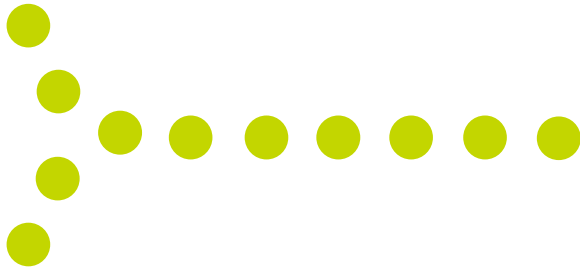

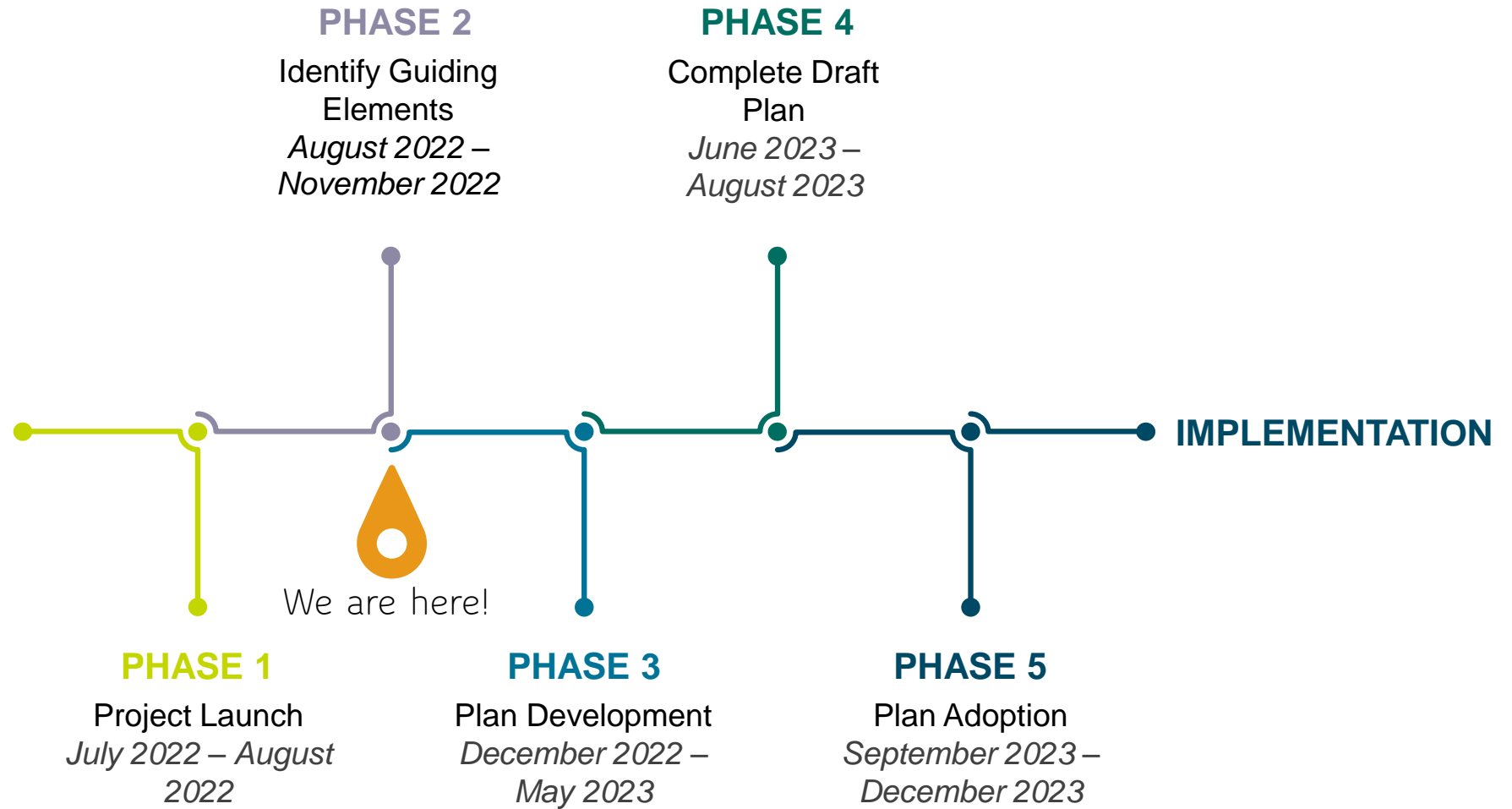
